#### **Program Information**

The Nursing Program at Southeast Tech started in 2001, with an LPN Diploma program. Health care industries in the region requested the LPN program due to unmet staffing needs in many facilities. Since that time, the LPN program has grown substantially and now has classes starting three times each year, plus a part time evening and a part time day program. In January 2012, the first courses were started for the LPN to RN AAS Degree. The number of students and staff in the Nursing Program has grown each year. The Nursing Program strives to meet industry needs and standards by utilizing excellent faculty and staff, incorporating rigorous curriculum, a variety of clinical experiences, and excellent skills training.

#### **Pinning Ceremony**

At Southeast Tech, the pinning ceremonies and graduation ceremonies are separate events. The graduation ceremonies are held with the entire Southeast Tech graduating class and are usually held in the Sioux Falls Arena. The Nursing Program pinning ceremonies are held on the Southeast Tech Campus and the Huron Community Campus. Students will receive more information near the end of the program.

#### **Student Guidelines**

The Nursing Program has established the following guidelines in addition to the policies of Southeast Technical College and those outlined in the Health Handbook. Please refer to the Health Handbook for health record requirements.

#### **General Expectations of Students**

Students accepted into the LPN program are nursing professionals. Therefore, professional behavior is expected during all school activities. This includes lecture, lab, clinical, and preceptor experiences.

All LPN students will be evaluated on a regular basis by LPN instructors and staff concerning professional and ethical behavior.

Students attending Southeast Technical College are expected to comply with all pertinent state laws and take responsibility for their conduct.

Students must have proof of being a current CNA.

The primary means of communication with students, outside of class, is the STC email system. Therefore, students are expected to check STC email frequently.

Professional language is expected at all times. Loud comments and boisterous behavior are not appropriate. Voice levels should be moderated, and appropriate judgment should be used in choice of words. No profane language will be tolerated. Tactfulness is expected.

Students are expected to maintain confidentiality at all times. This includes, but is not limited to, information learned verbally or in written format. Students are only permitted access to patient records that are relevant to a patient currently under their care. Students must sign an agreement to maintain confidentiality, which will be kept on file for each student. Any breaches of confidentiality will be considered grounds for immediate disciplinary action, including possible dismissal from the program.

Honesty in all communication is expected. Dismissal from the program may result if a student is dishonest, steals, cheats, comes to class/clinical intoxicated or under the influence of alcohol or controlled substances, or inappropriately uses social media (including any remarks about your patients or sharing any patient information). Dismissal may also result from a student making any disparaging remarks about your school, nursing program, students, faculty members and/or staff.

If a student is absent, it is the student's responsibility to find out what material was covered, and what can or should be made up.

Disruptions such as talking during the instructor and/or peer presentations, excessive movement around the classroom, or other behavior deemed disrespectful or unprofessional will not be allowed.

#### **General Course Guidelines and Grading**

Course specific requirements will be in the course syllabi.

Students who fail the same nursing course twice, or failure from a total of two nursing courses may result in dismissal from the nursing program.

#### Health, Illness and Injury Guidelines and Procedures

Students must notify the classroom and/or clinical instructor as early as possible of any illness that will cause an absence from the clinical site or the classroom. The instructor must receive notification at least 10 minutes before the starting time of clinical experience and/or class.

Students need to contact faculty member within one business day regarding any injury sustained while in the role of a Southeast Tech student.

Failure to comply with affiliate agreements regarding immunizations and physical requirements will result in you not attending clinical. Clinical will not be made up and you will receive a zero for a missed clinical day.

#### **Clinical Guidelines**

Students will receive a final clinical schedule for the courses once clinical sites have been finalized for a course or a semester. Clinical Agency Policies must be followed when in the clinical area.

Absences due to illness (vomiting, diarrhea, elevated temperatures or any contagious illness) may require doctor's verification. Students may wear a mask for the common cold. Treated infections after 24 hours of antibiotics are not contagious. Clinical make-up instructions will be provided at the beginning of the course. Students who have had surgery or have an injury must provide documentation from their physician that they are able to participate in clinical. Documentation must be provided before they are at the assigned clinical site.

Grade may be lowered due to clinical absences because credit for clinical experience cannot be given when you miss the experience.

Absences due to snow days: If STC is closed or the Associate Dean Curriculum & Instruction of Nursing cancels clinicals there is no drop in grade. However, the day may be rescheduled or completion of an alternative format clinical may be required. The lead clinical instructor and/or clinical coordinator will communicate with you whatn needs to be completed.

Promptness is expected. If a student is late for a clinical experience, the instructor has the option to dismiss the student from the clinical area without allowing them to participate that day.

Student/patient relationships must be professional only. Students are to have a therapeutic relationship with patients. It is not appropriate to spend time strictly socializing during clinical experiences.

If you will be late or absent for clinical, you must send an email with three individuals copied: your clinical instructor, the nursing programs Administrative Assistant <u>kristi.duus@southeasttech.edu</u> and the clinical course lead. You are not required to call your instructor or the course lead. In the event you need to call, the Nursing Program Administrative Assistant may be reached at 605-367-5728; please leave a detailed message including first and last name, student ID number, clinical site, and instructor \*prior to the start of clinical. For emergency contact, you may give site and school contact information.

Clinical paperwork may be available for reviewing 2 weeks after submission of the assignment

Grading in the clinical portion of the course is based on performance at the clinical site, as well as written assignments. The performance grade equals 65% of the clinical grade, the assignments (care plans, paperwork, etc.) equal 35%.

Instructors have the right to send students home for violations listed above, or if the instructor determines that the student's behavior may be harmful to the clinical site, patients, or other students. If asked to leave, students must do so in a respectful, courteous manner and the issue will be discussed at a later time on campus with the Instructor and the Associate Dean of Curriculum & Instruction of Nursing.

- **UNIFORM** Students who do not meet the dress code/uniform requirements will receive a 25% reduction in clinical and 50% reduction in lab grades.
  - General
    - Must be clean, wrinkle-free, and free of tears or stains
    - Must fit properly, not too tight, not too loose to reveal inappropriate anatomy
  - **Bottoms** 
    - Should be hemmed to ensure they do not drag on the floor
    - Must come up to the waist (NO low-rise scrub pants permitted)

#### • Undergarments

- Must be WHITE
- Undershirt should not hang lower than the scrub top
- Underwear should not be visible either above the scrub shirt or pants
- o Shoes

- Must be ALL WHITE
  - No other color combination of colors with white will be permitted
- Must be close-toed and full heel (no straps or low heel back such as clogs permitted)
- Badge
  - Must ALWAYS wear Southeast Tech ID name badge when in a **clinical or lab area**
  - Students doing clinical rotations at Veterans Administration Medical Center (VA) are also required to wear the VA name badge when at the facility

- Watches
  - Must have second hand; NO digital watches
  - Watches that send or receive messages are NOT PERMITTED
- o Hair
  - Should be clean, neatly combed and styled so it does not fall forward
    - Hair that is shoulder-length or longer must be put up
    - Bangs longer than eyebrow-length must be pinned back
    - Mustaches or beards must be kept neatly trimmed and close to the face
  - Must not touch the collar of the uniform
  - Accessories must be a solid\_neutral color (black, brown, white or clear)
    - •\_\_\_No feathers or non-hair type extensions permitted
    - Headbands are not to be over 2" in width
- Hygiene
  - Personal cleanliness, use of deodorant and good oral hygiene is an expectation
  - No perfume or cologne is permitted
  - No odor from tobacco use is permitted
  - Minimal amount of makeup may be worn
- ACTIONS
  - Cell phones
    - Must be in your backpack on silent or airplane mode for the duration of lab and clinical
    - Must not be on your person or make noise for the duration of lab and clinical
    - Must only be used when indicated by faculty (during scheduled breaks, authenticating)
- SUPPLIES and equipment MUST be in working order
- OTHER
  - Chewing gum must not interfere with patient care and is up to the instructor's discretion to determine if it is permitted or if it must be discarded
  - Chewing tobacco is not permitted

#### **Advanced Standing Guidelines**

The applicant must submit a request for advanced standing in the LPN program along with transcripts, course outlines, skill competencies, clinical evaluations, and other material requested by the Associate Dean of Curriculum & Instruction of Nursing.

After the Associate Dean of Curriculum & Instruction of Nursing has evaluated the material and determined there is possible equivalency to Southeast Tech LPN courses, the Associate Dean of Curriculum and Instruction of Nursing will meet with the Director of Student Services. A final determination of advanced standing will be made.

If there is space available in the class, the applicant will then proceed through the admissions process as outlined in the admissions policy and procedure.

If it is unclear to the Associate Dean of Curriculum & Instruction of Nursing if there is course equivalency, the Associate Dean of Curriculum & Instruction of Nursing may suggest credit by examination. The Associate Dean of Curriculum & Instruction of Nursing will make the final decision.

All students graduating from the Southeast Tech LPN Program must successfully meet all course and clinical requirements and competencies.

A student accepted, as an advanced standing student, must take at least 25% of the required Southeast Tech LPN program credits at Southeast Tech.

Advanced standing placement is given only if there is space available in the class.

#### Student Engagement

Nursing students are invited and encouraged to attend the Nursing Faculty meeting to voice their concerns or opinions. Students can attend the first 10 minutes of the meeting. The meetings are held every other week when possible on Friday during the fall and spring semester.
